- (2) Complete and detailed building plans, material listing and specifications**
- (3) Property site/plot plan showing the location of the proposed improvement**

FAILURE TO SUBMIT THE REQUESTED ATTACHMENTS (ITEMS 1, 2 & 3) PRIOR TO CONSTRUCTION MAY RESULT IN DENIAL OF YOUR REQUEST FOR IMPROVEMENT. If any change is made without approval, the Committee/Board has the right to request that homeowner remove the improvement from their property. Any homeowner considering any exterior improvement or modification to the property is urged to review the recorded deed restrictions prior to initial request.
